**THE LANCASHIRE COUNTY COUNCIL RESTRICTED BYWAY FROM BORWICK HALL
BRIDGE, BORWICK TO THE PACKHORSE BRIDGE, CAPERNWRAY DEFINITIVE MAP
MODIFICATION ORDER 2022**

On the 25th day of January 2023 Lancashire County Council confirmed the above Order.

The effect of the Order as confirmed is to modify the Definitive Map and Statement of Public Rights of Way for the area, by recording a restricted byway from junction with Borwick Lane on the west side of Borwick Hall Bridge running generally south along a bounded tarmac road to a junction with footpath 1-7-FP 9.

The route then continues along a bounded compact stone surface road to a junction with bridleway 1-7-BW13.

The bounded track turns east then east south east to a junction with footpath 1-7-FP8 and then in a generally southerly direction for approximately 800m passing under a railway viaduct where the route crosses the River Keer via a ford with a concrete walkway alongside and a packhorse bridge to meet Unclassified County Road U50230 which continues through to Capernwray Road.

The total length of the route is 1.34 km. and the width varies between 4m and 11m.

The Order took effect on the 25 January 2023, but if a person aggrieved by the Order desires to question the validity on the grounds that it is not within the powers of Section 53 of the Wildlife and Countryside Act 1981, or that any of the requirements of Schedule 15 to the Act have not been complied with in relation to the Order, he may, under Paragraph 11 of Schedule 15 to the Act, within 42 days from the date of publication of this Notice, make an application for the purpose to the High Court.
